### Information on Invoicing

1. Amounts charged have to be paid 14 days after invoicing. Payments have to be made in EUR in a single amount (no partial amounts).
2. All fees are index-linked. Basis for the indexation is the consumer price index 2015 (“CPI 2015”) released by Statistics Austria or any other index replacing it. The starting basis is the index number released for the month of January 2017. The fees are adjusted in value to the same extent as such index deviates from the starting basis. Changes of the index up to 3 per cent are not taken into account. However, if either this threshold is exceeded or the index falls below this threshold, the entire adjustment has to be made. The index number used for the adjustment of the fees constitutes the starting basis for their next adjustment in value. OeKB will publish all adjustments of the fees pursuant to this indexation clause on its website ([www.oekb.at](http://www.oekb.at)). Failure by OeKB to adjust the fees in value or to publish the adjustment in value is not a waiver to ask for such adjustment that may be made by OeKB any time thereafter.
3. Fees do not comprise VAT and are in EUR.
4. Invoicing of the basic fee will done once a year, invoicing of the data delivery on a half-yearly basis (June 30, December 31).
